B'luru hosts AUS

BENGALURU: In an attempt to foster international relationships, the Federation of Karnataka Chambers of Commerce and Industry (FKCCI) and the Rotary Club of Bangalore, joined hands with the Australian delegation. By building such a relationship a lot can be contributed to the world, said Nalini Nanjundia, president of the club.

The FKCCI and the club came together on September 6 at Sir M V Auditorium, Chickpet, to celebrate the collaboration and innovation Karnataka's micro. small and medium enterprises sector (MSME) and discussed the potential collaboration between Karnataka and the Australian state, Victoria.

The diverse sectors of interests including the opportunities for trade and partnership, with which both nations could benefit and grow together economically and culturally, were discussed. "We have identified many sectors of interest to you. such as IT, software services, biotechnology, aerospace and defence. agro-based industries, and hospitality, renewable energy, film entertainment industry, startup and innovation, and textiles and handicrafts. These sectors have a lot of new opportunities to collaborate, investment and vendor-based trade," said Gopal Reddy, president of the FKCCI.

"Victoria was looking to explore new opportunities to build on existing initiatives and to maximise the potential that exists," expressed Lee Tarlamis, Member of the Victorian Legislative Council.

Govt propose, officials dispose: Caste doc

BENGALURU: Despite the Tamil Nadu Government's decision to issue caste certificates to the Thurumbar community, also known as Puturrai Vannar, they find themselves in a challenging situation. The taluk administration across the state is waiting for the district collectors' approval, leaving the community without the benefits they are entitled to with these certificates.

Rene Jenner, representing Thurumbar Movement, an NGO dedicated to the community's welfare. highlighted the issue. "The government has issued an order for caste certificates for Puthurrai Vannar, but the Tehsildars responsible for issuing the certificates claim they need assent from collectors," Jenner revealed in an interview with The Beacon.

Many remain unaware of the existence of the Thurumbar

community, faces which discrimination, as they are often treated as untouchables, unable to venture outside their homes freely. Tragically, they are even denied the right to cremate their deceased public crematoriums, at conduct these having to ceremonies behind their own homes, he elaborated.

The community has also been grappling with incidents of rape, but the police have been reluctant to register FIRs.

Unfairly, the Thurumbar community is often grouped with the Aadi Dravida community, allowing others to claim their benefits and certificates. As a result, Thurumbar Liberal

Movement has taken action seizing several Taluk offices, advocating for the community's rights recognition. "Earlier, when a couple married, the bride spent her first night with a panchayat member from another caste, only later uniting with her lawfully wedded husband. This practice underscores

domination of Thurumbar caste by the Aadi Dravida caste," said Jenner.

The Thurumbar community's lack of social identity is primarily due to their restricted mobility. To address this issue and obtain the necessary certificates from the Tahsildar's office, Jenner mentioned that the community is receiving assistance from a Catholic priest, a sister, and a nun. The government has allocated Rs 10 crores for the community's development, leading to increased recognition, although some individuals still struggle to obtain their certificates.

Jenner emphasised their role in this movement, stating, "We are the voice of these people." Despite presenting evidence, the Tahsildars remain reluctant to issue the certificates, leaving the Thurumbar community in a protracted struggle for their rightful identity and benefits.
