## Fishermen community sceptical of govt aid

As the fishermen community in Kerala struggle to tide over losses due to the recent flood, the state government on Wednesday announced a financial aid of Rs. 3000 per month to fishermen families. However, most of the fishermen are unaware of the move and remain doubtful as to when they would receive the amount, or if they would receive it at all.

The Government declared that Rs. 47.84 crores from Chief Minister's Distress Relief Fund would be allotted for this purpose. Abdul Khader, a fisherman from Kochi told The Beacon, "I was not aware of this decision until now. But if it is true, it would be beneficial only if we get the money soon."

On being asked whether the allocated amount would suffice, he added, "Most people from my community are suffering from the extreme financial crisis for the past two months due to a ban on fishing. At this time, any amount of money would be of huge help." Michael, another fisherman, also said that he was unaware of the move. "We are always the last people to know of such schemes usually," he said.

The current scheme would benefit about 1,59,481 fishermen families who were affected by floods. Earlier, the state government had sanctioned financial aid of Rs. 1200 per month for a period of six months.

## SC hears petition challenging Modi

Supreme Court on Thursday continued the hearing of Zakia Jafri's petition challenging the clean chit given by the Special Investigation Team (SIT) to the then Gujarat CM Narendra Modi and others involved in the 2002 Gujarat riots. Zakia Jafri lost her husband, Congress MLA Ehsan Jafri, to the Gulberg Housing Society Massacre during the Gujarat riots of 2002. The widow filed a complaint on 8 June 2006 before the Director-General of Police saying that the riots sprung out of a larger conspiracy. Since her FIR wasn't registered and the High Court refused to be involved, she was forced to move the Apex court. The SIT constituted was directed to look into

Zakia Jafri's complaint by the SC. Zakia Jafri took to the SC through a Special Leave Petition challenging the SIT's closure report. The SIT's closure report of 2012 concludes that there is no criminal offence commit-

ted by the state and suggested the closure of the case. The report gave a clean

chit to Modi and other high functionaries who allegedly favoured those who engineered the riots. In the past three days, Advo-

## Health officials in Kerala clueless about the online health portal

KERALA: The health officials and patients in Kerala remained clueless about a new decision on booking tickets through the e-health portal made available by the Health Department on Tuesday. Few details about the online facility of booking tickets are mentioned on the website of the department, however, people were unable to download the M e-health app. With the launch of the portal only the hospitals which are registered under the project are meant to be streamlined through the initiative. Shobha P, head nurse in the

super speciality division at Medical College, Alappuzha said, "No written circulars or guidelines were received from the health department yet, hence the working and effectiveness of the online

service can't be predicted. The launch of the portal was informed via newspapers leaving the officials confused without internal guidelines." Sona P.S, Assistant Professor at Medical College,

Alappuzha said "Since health officials are not informed well in advance about the implementation of the app, we are unable to genuinely help the patients especially the less tech-savvy ones."

The 2002 Gujarat riots broke out on 27 February when two carriages of the Sabarmati Express carrying Karsevaks from Ayodhya were burned at a Muslim neighbourhood in Godhra, killing 58 passengers. This gave rise to Hindu-Muslim clashes all over the state that claimed over a thousand lives. Mobs set homes and the business establishments of Muslims on fire and destroyed the mosques and cemeteries as well. The state government was criticised for not bringing the situation under control soon and for not taking adequate action against the perpetrators.
