India have increased : significantly,

particularly in the states such as Rajasthan, Haryana, Jharkhand and Delhi.

Rajasthan recorded the highest number of cases registered with a count of 941. It is followed by Haryana with 163 cases, Jharkhand with 54 cases, and Delhi with 46 cases in 2020. According to the report published by National Crime Records Bureau, a total of 3,71,503 cases of crime against women registered during 2020. An upward trend has been discovered in the number of rape cases in the abovementioned states between 2018-20. Rajasthan recorded 556 cases in the year 2018 whereas, in 2019, the cases increased by 346 with a total of 902 cases. Similarly, Haryana, Jharkhand, Delhi also showed an upward trend. 
In 2020, out of 43 custodial deaths that were recorded in India in the The gang-rape cases in : category 'not on remand', no policemen were convicted.

> As per the Indian Penal Code, a person arrested should be produced before the magistrate within twentyfour hours of the arrest. This means these deaths have occurred even before the accused was produced before the court.

> This was revealed in the latest Crime In India data released by NCRB last

Surprisingly, 40% of these custodial deaths have taken 15 and interestingly no place in the states ruled by the BJP government.

recorded the highest number Maharashtra has recorded 5 deaths and yet again no convictions have occurred.

> Tamil Nadu has recorded four custodial deaths whereas Karnataka has recorded three.

States such as West Bengal, Telangana, Punjab, Odisha, Madhya Pradesh, Bihar and Assam have reported 1 custodial death each.

Although few arrests have

been made in states such as Karnataka, Madhya Pradesh, Maharashtra and Andhra Pradesh, none of them are convicted yet.

"Custodial deaths absolutely against Article 21 of the constitution. 43 custodial deaths of people who were not in remand is a shocking revelation," said C.S.Rajan, Tamil Nadu State Citizen President of Movement for Equality, based in Madurai. He added, "At the same time, we cannot completely rely on the data set, as many custodial deaths also go unreported. I have dealt with some cases of custodial deaths where the bodies have been thrown into the well without reporting it." (With inputs from Pranav Shriram)

Communal murders increased by 70%

Despite the total number of crimes in India dipped in 2020, the murders owing to communal reasons has risen by 70% as compared to 2019.

This significant rise is witnessed because of the 53 deaths that were reported in Delhi during the riots that shocked the capital city in the aftermath of a protest against CAA-NRC. The nine other deaths are spread across the states.

Domestic violence cases decrease in 2020

omestic cases have been on a decrease post-2019. Records Bureau (NCRB) data 2020, the total number of cases of domestic violence reported in India decreased in 2020 as compared to the previous year.

The year 2020 has seen an decrease compared to that of 2019 in terms of the total cases reported. Karnataka specifically has seen a 17% decrease whereas other states 21.03% decrease in domestic violence cases.

It is essential to note that the decrease is just in the cases reported. Analysts attribute the cause of the decrease to the lockdown that was imposed in the year 2020.

Cases reported have risen in certain states as well, like West Bengal (17.76% increase) and Odisha (33.58% increase). However the majority of the states in the country have a lesser number of cases reported in the year 2020. (With inputs from Riya Joseph)
